Most of the leading Senior Advocates, Advocates, Chartered Accountants and Tax Practitioners from different parts of our country as well as 135 leading Tax Professional's Associations/Tax Bar Associations from 18 States are Associate Members of this unique Federation.

AIFTP has an 'Indirect Tax (GST) Representation Committee' as well as 'Direct Tax Representation Committee' to monitor and suggest the right path for a well-designed and ideal Indirect & Direct Tax Regime as well as to educate the tax fraternity about the finer aspects of the Tax Law implemented in our country.

We at AIFTP think that 'Simplicity, Clarity and Transparency' are essential elements of a good system of collection of Indirect Tax.
