2. Extension of Due Dates for various Compliances

Due to unprecedented lockdown owing to COVID 19 the Government had extended the time for filing of returns and various other compliances in phased manner to the end of June, 2020 vide various notifications dated 03.04.2020. The COVID 19 lockdown continued till 31st May, 2020 throughout India and was lifted in stages on 1st and 8th June, 2020. It continues to be in force in many metro cities of the country till 30th June, 2020. With public transport not functioning, it is difficult to have sufficient or required staff to prepare the data. We, therefore, request that various due dates notified for on or before 30th June, 2020 and July, 2020 be extended to 31st August, 2020 without interest and late fee.
