Observations by the Election Officer:

The findings of the Election Officer on the basis of reports submitted by HO and respected Chairman Mr. Sandeep Agarwal (AIFTP-CZ):

- That according to the clause 7(A) of Nomination Form, all the candidates have qualified two years standing of the zone and have completed five years in practice.
- That according to clause 7(B) of Nomination Form, all the existing members of managing committee have attended more than two meetings of managing committee as per the report of the Zonal Chairman.
- That contrary to clause 7(C) of Nomination Form, no woman has filed any nomination form. Hence, one seat for woman is vacant.
- That according to clause 7(D) of Nomination Form, Mr. Rajesh B. Doshi (Chartered Accountant) from Raipur (Chattisgarh) has supplied one cheque of Rs. 2950/- dated 11.10.2023 and the same has sent to bank for

clearance. Rest of members have deposited the nomination fee through online transfer. (The entire copies alongwith nomination forms sent to HO).

- That clause 7(E) of Nomination Form also stands complied with only one exception, of Mr. Rajesh B. Doshi who is a single nomination from Chattisgarh. Hence, one seat from Chattisgarh is vacant.

The above findings have been supplied to HO for appropriate action.
