ELECTIONS TO THE NATIONAL EXECUTIVE COMMITTEE OF AIFTP FOR THE TERMS 2024 AND 2025 AT KOLKATA

INSTRUCTIONS FOR STRICT COMPLIANCE BY THE VOTERS DURING VOTING

- 1. Kindly affix "⊕" mark against name of the candidate to whom you are voting for on the ballot paper. A seal would be provided for affixing this mark on the ballot paper. Any other mark will be treated as **invalid**.
- 2. A voter has to affix a mark against total electable candidates of the respective zones (6 posts in Northern Zone, 9 posts in Eastern Zone, 11 posts in Southern Zone and 13+1 posts in Western Zone).
- 3. Ballot having marks "more than or less than" electable candidates of the respective zones shall be treated as **invalid** of that particular zone only.
- 4. Voters have to ensure to cast one vote for a lady candidate compulsorily and remaining 13 votes could be casted to the General Category Candidates including remaining Women Candidate in **Western Zone**.
- 5. The seal should be clearly affix in the space provided and marking of the seal partially in more than one space shall be liable to be treated as **invalid** of that particular zone only and not the entire Ballot paper.
- 6. Voters should be members of the All India Federation of Tax Practitioners (AIFTP) on or before **31**st **October 2023** only.
- 7. Voters should present their legally valid Government approved Photo **Identity Cards** with **their name clearly visible**, at the time of voting to the Election Officer and/or volunteers.
- 8. In the case of Association Member, voting can be done by a Representative, whose name has already been intimated to AIFTP in

- writing at least one month prior to the election in term of Rule 5(C)(ii) of the Federation.
- 9. Further, such representative will be required to produce a copy of said intimation letter as stated above alongwith a copy of legally valid Government approved Photo Identity Cards with their name clearly visible, at the time of voting to the Election Officer.
- 10. Voters shall vote at the booth allotted and submit the vote in the ballot box provided and move out of the polling station.
- 11. Candidates and/or their supporters and/or Voters shall not canvass in the polling area for other candidates.
- 12. Chief Election Officer shall have a discretion to not allow any voter to vote or treat his vote as invalid, in case any of the above instructions are not properly followed.
- 13. All complaints in relation to the polling process shall be made to the Chief Election Officer only in writing.

14. All the voters are required to drop their ballot in the ballot box only.

15. Decisions given by the Chief Election Officer shall be final and binding on all.
