

High Court

 S. 4: Principles of Mutuality applicable to the trust's income even the amount received from nonpermanent and non-life members.

The Assessee was a recreational club but registered as a society, and received amounts from both its permanent and life members as well as non-permanent and non-life members. The Assessing Officer held that the principle of mutuality would not apply in the case of non-permanent and non-life members and amounts received from such members were included in the income of the assessee. However, while deciding the issue the Tribunal observed that for preceding the assessment year 2000-01 and succeeding assessment years 2002-03 and 2003-04, had taken a view that even if there were non-permanent, non-life, temporary or honorary members who were not entitled to vote, assessee-club would not cease to be governed by principles of mutuality.

The Honorable High court observed that, the doctrine of mutuality, based on common law principles, is premised on the theory that a person cannot make a profit from himself. The contributors to the common fund must be entitled to participate in the surplus and the participators in the surplus are contributors to the common fund. The principle postulates that what is returned is contributed by a member. Any surplus in the common fund shall, therefore, not constitute income but will only be an increase in the common fund meant to meet sudden eventualities. Held that, once assessee was governed by the principle of mutuality, its income would not be construed to be an income within meaning of Act and liable to be taxed, even with reference to transactions entered into by assessee with non-permanent and non-life members.

Jubilee Hills International Centre vs. ITO, ITTA No. 205 of 2005 dt.04/01/2023 (Telangana)(HC)

2. S. 89: Relief on salary or arrears amount paid in advance under VRS is eligible, even after assesse claimed relief u/s. 10(10C).

The Assessee was an employee of State Bank of Hyderabad, he opted for voluntary retirement under the voluntary retirement scheme (VRS) framed by the State Bank of Hyderabad. He received compensation in the form of ex-gratia in Form No. 16 issued by the employer, out of the ex-gratia received, Assessee claimed part amount as exempt in terms of section 10(10C), and the balance amount as part of his taxable salary. The Assesee however treated this amount as salary received in advance and claimed relief u/s. 89 of the Act. The Assessing Officer allowed claim of the assessee for exemption u/s. 10(10C) and declined claim u/s. 89 for the remaining amount.

The Honorable High Court held that the issue of admissibility of relief u/s. 89(1) on payment received under the voluntary retirement scheme had been examined by CBDT wherein it was clearly stated that relief u/s. 89 would be available to the assessee on payment received under VRS. Once the relief was granted u/s. 10(10C), further relief u/s. 89 would be available to an assessee. Hence the Order passed to the extent of denial of benefit to assessee u/s. 89 was not justified.

N.S.R. Murthy vs. CIT, WP No. 17116 of 2008, 25/01/2023 (Telangana)(HC)

 S. 144B - Faceless assessment - Opportunity of personal hearing rejected by the AO, Principle of Natural Justice Violated.

The application for a personal hearing was made by the assessee through Video Conferencing with the concerned assessing authority. The said application was duly received by the Department also. However, in spite of the application having been duly received by the Department, the authority concerned proceeded with the assessment proceeding and passed the impugned order without giving a fair opportunity for a personal hearing.

The Honorable High Court held that it is mandatorily required by the assessing authority for giving an opportunity of hearing upon an application with a request for hearing when made. The principles of natural justice, particularly when the Act itself provides for a procedure for the same, stand violated. Matter was remanded to the Assessing Officer to provide the opportunity for a personal hearing.
