### Direct Taxes Ms. Neelam Jadhav, Advocate, KSA Legal Chambers

#### High Court

 S.37(1) : Business expenditure – Expatriate Cost – Deduction claimed with respect to expatriate cost incurred by its PE on employees of assessee who were monitoring marketing activities of said PE, without adjudicating aspect of existing contractual liability between assessee and its employees, disallowed expenditure is not justified.

The Assessee foreign company set up a branch office in India for providing market support services to its group entities. Assessee claimed deduction u/s. 37(1) for expatriate cost incurred by assessee's PE on employees of head office who were monitoring marketing activities of said PE. The AO disallowed claim on ground that assessee could not establish commercial expediency in incurring expatriate cost. Contention of the Assessee that, expatriate cost was included in operating cost on which marked up had been earned by PE and offered for tax.

The Honorable High Court held that, since no adjudication was made by AO on aspect of any existing contractual liability between assessee and its employees, the said impugned order was required to be reconsideration as the expenditure of expatriate cost should be given deduction from operating cost or not.

 S.40A(3) : Business disallowance – Cash payment exceeding prescribed limit – since affidavits filed during assessment proceeding contained clear recital that sellers insisted for cash payment, identity was not in doubt, and sale deeds were also admitted to be registered document, no disallowance u/s. 40A(3) was called for.

The assessee had purchased agricultural land from certain persons who did not have bank accounts or easy access to banking services and that in any case they had pressed for urgent payments to be made, if the sale were to fructify. The purchasers filed their affidavits during the assessment proceedings. In support of the aforesaid contentions they acknowledged the sale transactions. Further, disclosed their true identities. The sale having been evidenced by a registered sale deed, there was nothing to doubt the genuineness of the transactions, yet, the Tribunal has overlooked these admitted facts and taken a technical view by relying on the provisions of s. 40A(3) r.w. second proviso thereto, as then existed on the statute book.

The Honorable High Court observed that, in assessment proceeding affidavits filed by the Assessee were not rebutted by the revenue. Affidavits contain clear recital that the purchasers insisted for cash payment. The sale deeds are also admitted to be registered documents and there is no other material as may be considered adverse to the claim set up by the assessee. Held that, no disallowance u/s.40A (3) if purchaser insisted for cash payment.

Smt. Sangeeta Verma v. CIT ITA No. 416 of 2012, dated 08/10/2021 (All)(HC), Source : www.allahabadhighcourt.in

 S.153C: Assessment in case of person other than person searched – Addition u/s.153C is not sustainable where on perusal of the seized document could not be inferred or concluded that seized document belonged to or had any nexus with the assessee.

The Honorable Tribunal confirmed the assessment order holding that assessee had discharge its onus to prove genuineness of sale transaction with regard to shop. The Tribunal in its order has concluded that there was no corroborative evidence or statement to prove that payment had been received by assessee other than cheque amount as entered in sale agreement, perusal of seized document it cannot inferred or concluded that seized document belongs to or has any nexus with assessee. There was no corroborative evidence or statement to prove that the payment had been received by the assessee other than cheque amount as entered in the sale agreement.

Honorable High Court observed that, the name of the assessee nowhere appears in the computer generated loose sheets found from the residence of searched person that is the alleged broker. Therefore held that, addition u/s.153C is not sustainable where on simply perusal of the seized document it could not be inferred or concluded that seized document belonged to or had any nexus with the assessee.
