Report on Two Days National Tax Conference - Delhi Saturday & Sunday, 06th & 07th August, 2022

All India Federation of Tax Practitioners (North Zone), in association with GST Bar Association, Varanasi and Ghaziabad Bar Association, Ghaziabad organized a Two Days National Tax Conference on 06th & 07th August, 2022, Saturday & Sunday at "India Habitat Centre (IHC), Lodhi Road, Delhi. Theme of Conference was Tax Professionals – Strong Pillar For Nation Building. 312 delegates participated in the National Tax Conference from all over the country including Varanasi, Amritsar, Ludhiana, Mumbai, Thane, Agra, Ghaziabad, Noida, Jammu, Meerut, Saharanpur, Prayagraj (Allahabad) Lucknow, Jaunpur, Banglore etc. and from Delhi.

High Court

 S.149: Reassessment Notice - Limitation - Notice issued for AY 2015-16 and subsequently issued by way of corrigendum for AY 2010-11, said corrigendum was time barred, jurisdiction to reopen assessment for AY 2010 - 2011 not valid. AO cannot rectified notice by issuing corrigendum. (r.w.s.292B)

The Assessing Officer issued notice for reopening to determine escaped income for AY 2015-16 and subsequently by way of corrigendum, Assessing Officer sought to correct mistake in original notice and stated that same was issued for AY 2010-11.

The Honorable High Court held that, said corrigendum could not be said to have cured a procedural irregularity as contemplated under section 292B, therefore the Assessing Officer has invoked jurisdiction to reopen assessment for AY 2010-11 by way of issuance of corrigendum which was time barred. (AY 2010-2011)

Infineon Technologies AG vs. Dy. CIT (International Taxation), W.P. 49458 of 2018 dt.24th JUNE, 2022 (Karnataka)(HC)


 S. 276C(1): Offence and Prosecution - Exemption claimed under section 54F which was not accepted by Assessing Officer and subsequently, tax was also paid, prosecution could not have been initiated for willful evasion of Tax The Assessing Officer has disallowed deduction claimed under section 54F on ground that assessee had purchased an industrial property. Penal proceedings were also initiated under section 271(1)(c) for wrong claim of deduction under section 54F. It was case of that prosecution that accused had willfully attempted to evade tax by making a false claim, which were not allowable under provisions of Income Tax Act. Hence, the Assessing officer held that accused had committed an offence under section 276C(1) and show cause notice was issued and since reply was given by accused was not satisfactory, and prosecution was initiated under section 276C(1) and 277 on the petitioners.

The Honorable High Court held that, claim of the assessee was bonafied, there was no suppression of facts and assessee has originally disclosed receipt of sale property and therefore it cannot be said that merely exemption is claimed to property and investment has not been made. Income has not suppressed, only exemption has been claimed. In penalty proceedings that no suppression of materials, it is only bona fide. The High Court held that prosecution is nothing but futile exercise and abuse of process of law. (AY 2012-2013)
