#### **Direct Taxes**

#### **High Court:**

 S. 148: No reassessment can be done merely because another director disclosed income from the sale of shares under a different head of income. (r.w.s.45 & 16)

The Assessee and one 'M' held shares and rights in a company called "D" and both were directors in said company. Assessee transferred shares and rights in company 'D' for a certain amount and disclosed income under head Capital gain. The AO being satisfied with the information and documents submitted by the assessee passed the order under section 143(3) accepting the disclosed income. Subsequently, AO issued notice u/s. 148 to the Assessee seeking to reopen the assessment for reasons that 'M' had also transferred shares and rights in company 'D' and disclosed income under head Income from salary and thus amount received by the assessee was required to be taxed under head Income from salary.

The Honorable High Court observed that, the AO has not specifically mentioned in the order, what was the tangible material, to conclude that there was an escapement of income, and also failed to aver what material fact the assessee has failed to disclose fully and truly. Based on the case of 'M' who had disclosed his income under the head Income from the salary the AO sought to reopen the case. Apart from different heads on which the assessees have offered their income to be taxed, there is no other ground based on which the AO is seeking to reopen.

Held that, there is a full and true disclosure upon which transaction has been accepted under the head claimed by Assessee. Merely because another director of the same company had disclosed the income received differently, it cannot be a ground for reopening and the same is evidently a change of opinion.

Deepak Marda vs. ITO, WP No. 8010 of 2022, 18/01/2023 (Bom)(HC)

 S. 2(47): Capital gains - Transfer (Conversion of partnership firm into a company) - mere review assessment is not justified for reopening. (r.w.s. 45 & 147)

The Assessee was a partnership firm involved in real estate development which consisted of four partners, with the first three partners jointly purchasing land, which was taken as stock-in-trade by the firm. The fourth partner provided the entire fund required for the real estate business. As per the partnership deed, first and third partners transferred their right, title, and interest in land to the firm, which was treated as their capital contribution. The Assessee initially showed cost of land as stock-in-trade in its balance sheets for years ending 31-3-2006 and 31-3-2007 - However, on 31-3-2008, land and building held by firm were revalued and converted from inventory to fixed assets. Revaluation exercise resulted in enhancing value of assets, and partners of firm withdrew a substantial amount from its capital. Enhanced value after revaluation was entered in a separate account created as partners' current account, where amount was credited in name of partners - Partners' capital balance as on 31-3-2008, was significantly reduced due to the withdrawal of funds. The Assessee was later converted into a Limited Company, and partners' current account was converted into a loan, shown as a liability in the books of the company.

Subsequently, the assessment was sought to be reopened on ground that capital gains arising out of revaluation of profit on conversion from capital account of partners to loan is the transfer of assets and is to be taxed as income in the hands of the assessee and this aspect had not been examined by Assessing Officer in his scrutiny assessment. The assessee had produced copies of the partner's capital and current accounts together with their audited accounts as also details of fixed assets were furnished by assessee during the original assessment proceeding. In original assessment proceedings, AO raised a specific question as to whether the revaluation amount could be assessed to tax, and such query was duly re-plied and Assessing Officer accepted that the revaluation amount was not income or taxable and no addition was made in the original assessment order.

The High Court held that, the reopening of the assessment as it was a mere review assessment made originally. Hence reopening is not justified.
