## **Report National Tax Conference held in Puri on 3rd and 4th February with a Chilika Lake & Konark Trip on 5th February 2023**

The Two day NTC held at Puri, Odisha was organised under the guidance and mentorship of Dr. Ashok Saraf. The said conference along with trip to Chilika Lake & Sun Temple in Konark was planned, executed and organised within a short span of 35 days under the leadership of Conference Chairman Senior Advocate Sri.
