

Direct Taxes

High Court:

 S. 4: Income - Capital or revenue receipts - Interest on unutilized subsidy received for a capital project not taxable.

Interest received by the assessee from short-term deposits made out of unutilized capital subsidy, unutilized debt funds, and unutilized equity funds received as capital during the formative years till the project was completed, was rightly claimed under the head of capital receipts. The stand of the revenue that this interest income should be treated as revenue receipts so as to make it taxable income is not acceptable.

Pr. CIT v. Brahmaputra Cracker and Polymer Ltd. ITA No. 13,15 & 16 of 2022, dt.12/04/2023 (Gauhati)(HC)

2. S.179: Company in liquidation - Liabilities of directors (Scope of provisions) –limited role of the assessee as a director in a company - outstanding dues quashed.

The AO passed order u/s. 179 holding that petitioner as director of the company was jointly and severally liable for outstanding taxes dues. The high court held that, the director of the company submitted all documents in support of his claim that he was not in controlling capacity of the company especially its financial affairs, also perusal of documents showed that after removal from directorship which took place

in the year 2009 itself, assessee had no connection with the said company or any access to its companies affairs. Since lack of financial control, lack of decision-making power, and having a very limited role in the company even as director, and the entire decision-making process being with other directors appointed by the largest shareholder of the company. Hence assessee is not liable for outstanding dues.

PrakashB. Kamat v. Pr. CIT, WP No. 3129 of 2019 dt.12/06/2023 (Bombay (HC)

 S.41: Not considering the reply of the assessee, Penalty levied deserved to be set aside for de novo. (Black Money (Undisclosed Foreign Income and Assets)

The Assessing Officer issued a show cause notice u/s. 41 proposing to levy a penalty. The Assessee filed a reply stating that penalty proceedings should be kept in abeyance having regard to the fact that the appeal preferred on quantum, was pending before Commissioner (Appeals). The Assessing Officer without taking into account the reply, levied a penalty on the High Court and held that, the penalty order deserved to be set aside to conduct a de novo exercise.
