

## Report of 26th National Convention held from 22nd - 24th December 2023 at Kolkata

Kolkata based tax advocate Narayan Jain has been elected National President of All India Federation of Tax Practitioners (AIFTP) for 2024 in National Convention presided over by Adv. Pankaj Ghiya. Justice Rajesh Bindal, Judge of the Supreme Court of India administered oath of Office to Jain and appreciated the functioning of AIFTP and training of tax practitioners to update their knowledge so that they can represent the matters well. In the changing scenario in Courts as well as Income Tax Department the compliance of notices is to be done online so it is imperative that the practice skill is developed added Justice Bindal. Justice Moushumi Bhattacharya of Calcutta High Court also addressed as Guest of Honour and conveyed her good wishes for the success of the Convention.

In his acceptance speech Jain reiterated that the new team will focus on programmes for inculcating Ethics, spreading Education and ensuring excellence in profession of members of AIFTP. Outgoing President Pankaj Ghiya highlighted the activities during his tenure and thanked his committee and all members. The awards were also given for 2023.

Adv. RD Kakra was appointed as National Secretary General; Adv. Samir Jani as National Deputy President and CA Anil Mathur as the Treasurer for 2024. CA Dr. Debasish Mitra emphasised the need to cope up with emerging global scenario of Artificial Intelligence. Debayan Patra highlighted the role of ICAI in implementing new concepts in tax as well as audit in digital age. Other speakers Ganesh Purohit, Sumit Nema, Jinesh Vanzara spoke on Natural Justice and Panch Pran Tax Doctrine. PC Joshi chaired the session on Fake Invoices and litigation arising therefrom which was addressed by CA S. Venkataramani, Mukul Gupta and Sanjeev Anwar. Justice R.V. Easwar former Judge of Delhi High Court highlighted the importance of Money Laundering Act. It was well explained by Adv. Aditya Ajgkaonkar and G Baskar.
